Payment for subsequent years is made in accordance with the accounting document issued every 12 months, unless PFSz receives other instructions from the supporting member, including resignation from membership.

GDPR CLAUSE

I. Principles of processing personal data in connection with membership in the Polish Federation of Hospitals (fulfilment of the information obligation under Art. 13 and Art. 14 GDPR).

1. Polska Federacja Szpitali, Polska Federacja Szpitali, ul. Nowogrodzka 11, 5th floor, 00-513 Warsaw, Poland, is the controller of personal data and processes the personal data of:

a) Persons authorised to represent entities belonging to the Polish Federation of Hospitals: first name, surname, contact number, position, e-mail address, for the purpose of performing activities related to membership in the Polish Federation of Hospitals, in particular the exercise of rights and obligations arising from the statute of the Polish Federation of Hospitals, and also for the purpose of sending a newsletter containing PFSz news, pursuant to Art. 6(1)(f) GDPR - this data is contained in the membership declaration.

b) First name, surname, contact number, e-mail address, NIP (Tax ID), position, address of the natural person who is a member/partner of the Polish Federation of Hospitals, for the purpose of performing the contract pursuant to Art. 6(1)(b) GDPR (performance of the contract binding the member/Partner with the Polish Federation of Hospitals) or Art. 6(1)(c) GDPR (in particular for the purpose of settlements in accordance with applicable regulations and the exercise of members' rights and obligations arising from the regulations) - this data is contained in the membership declaration.

c) First name and surname, position, business e-mail address and business telephone number of the management of medical entities that are members of the Polish Federation of Hospitals - this data is contained in the membership declaration or obtained from publicly available sources, including the National Court Register (KRS) and the website of the medical facility, for the purpose of performing activities related to membership in the Polish Federation of Hospitals, in particular the exercise of rights and obligations arising from the statute of the Polish Federation of Hospitals, and also for the purpose of sending a newsletter containing PFSz news.

2. Personal data will not be transferred to third countries.

3. Personal data may be disclosed to entities that provide technical and administrative support services to PFSz.

4. Personal data will be stored for the period of membership in PFSz, and also for the period until claims between PFSz and the member/partner of PFSz become time-barred.

5. Providing the personal data indicated above in points 1a and 1b is necessary for the performance of the contract and for joining PFSz; refusal to provide it prevents remaining a member or establishing cooperation with the Polish Federation of Hospitals in another form.

6. You have the right to:

- request access to personal data concerning you;
- request their rectification;
- request their erasure;
- request restriction of their processing;
- object to their processing;
- request the transfer (portability) of personal data;

7. You have the right to lodge a complaint with the supervisory authority, i.e. the President of the Personal Data Protection Office in Warsaw, in connection with the processing of your personal data by PFSz.

8. Your data will not be processed for the purposes of automated decision-making, including profiling.
